Fannie and Freddie Allocate Money to the National Housing Trust Fund

Earlier this month, Fannie Mae and Freddie Mac <u>delivered \$186 million to the National Housing Trust Fund (NHTF)</u>, as required by Congress and their regulator, the Federal Housing Finance Agency. This marks the

inaugural allocation to the NHTF, which was created by Congress in 2008 to support the construction, preservation and operation of affordable housing for America's lowest-income families. As we previously reported, the National Low-Income Housing Coalition has published estimates of how the NHTF dollars would flow to states. NLIHC expects California to receive the largest allocation (\$13.1 million), while 32 states and the District of Columbia will receive the required minimum allocation of \$3 million. Land-Banking: A great tool for affordable housing development

Land-banking is a tool to use to preserve space for the development of affordable housing. The WA State Housing Finance Commission's <u>Land Acquisition Program (LAP)</u>—often in partnership with <u>Impact Capital</u>—offers this tool to any nonprofit housing developer.

Flexibility and strategic planning are this program's key benefits. By helping nonprofits purchase land now for development later, LAP allows them to take advantage of current prices and get control of the site early on, before getting the rest of the financing.

The Land Acquisition Program is a revolving loan program with low rates, created by the state legislature in 2007 and matched by Commission funds. It's been used all over the state for both multifamily and single-family development.

To date, LAP has loaned more than \$10 million, paving the way for 21 new housing projects with 946 units—including 108 single-family homes.

What's more, "team underwriting" by the Commission and Impact Capital can make LAP even more accessible and make financing go even further for nonprofits. Once the Commission's and Impact Capital's financing are blended together, interest rates are very low—often just over 2%.

And it can be done fast. A LAP deal can be closed in 60 days—putting nonprofits in a position to compete with for profit developers.

2016 Legislature in Special Session

The 2016 WA State Legislative Session ended earlier this month with operating and capital budgets still in negotiation. The Governor immediately called for a

special session. Housing advocates continue working for an investment in the State's Housing Trust Fund and increased revenue to support programs that reduce homelessness.

Some housing-related bills did pass during the initial session. Among them are

SB 6413 – Tenant Protections Act: Creates a new process for tenants to remove evictions from tenant screening reports and provides landlords with an additional 7 days in which to post-mark the return of a tenant's deposit.

3SHB 1682 – Homeless Student Stability Act: Improves the educational outcomes for homeless students through in-school guidance and housing stability.

Affordable housing reduces health care costs

A study conducted by the Center for Outcomes, Research, and Education (CORE) and sponsored by Enterprise Community Partners found affordable housing reduced overall health care expenditures by 12% for Medicaid recipients. Researchers attribute these savings to more cost-efficient use of health services, with an 18% decrease in costly emergency department (ED) visits and a 20% increase in less costly primary care services. The cost savings came without compromising access or quality of care to residents.
